

BOC Becomes Governing Member of FARB

Membership is a step foward for Athletic Trainer representation in the regulatory community.

The BOC recently became a governing member of Federation of Associations of Regulatory Boards (FARB), an important milestone in advancing regulatory excellence in the athletic training profession.

Like the BOC, FARB's mission is concerned with public protection. Where the BOC focuses on credentialing programs for healthcare professionals, however. FARB's mission as an association of associations is to "advance excellence in regulation of the professions in the interest of public protection."

BOC Executive Director Denise Fandel said FARB, which represents over 12

million licensed professionals, is a great fit for the BOC.

"Our membership in FARB provides the opportunity to increase the visibility of Athletic Trainers within the regulatory community and partner in broad issues of certification, professional regulation and public policy," Fandel said.

Governing members of FARB are associations of regulatory boards and other not-for-profit associations determined by the FARB Board of Directors to administer programs and services consistent with FARB's tax status and mission of public protection. The benefits of FARB membership extend to all governing member associations' staff, appointed leaders and elected volunteer leaders.

Group Discusses Maintenance of Competence

The BOC is dedicated to a quality certification program that helps ATs maintain their competence and use best practices throughout their career. Certification maintenance requirements assure the ATC® credential is a sign of quality. As indicated in the last issue, the BOC is piloting an Athletic Trainer Portfolio system and has commissioned a Maintenance of Competence (MOC) Task Force.

AT Portfolio

Because healthcare is a dynamic field, we continuously seek to provide innovative ways for the AT to develop and maintain competence. A pilot study of a new Athletic Trainer Portfolio system will help ATs identify and design a personalized CE experience.

We have encouraged participants to complete the first 4 steps by the end of April. As of May 3, over 40% have completed the 4th step. The pilot study will conclude December 31, 2017.



The MOC Task Force met April 1-2 and discussed the following charges:

 Identifying strategies that allow ATs to demonstrate maintenance of competence beyond accumulation of CE credit alone

- Recommending enhancements of the current certification maintenance system, which will allow ATs to maintain their competence through varied educational and assessment activities
- Identifying the components of the self-assessment module(s) and the subject matter areas that can be offered for future CE credit

The task force will continue to meet and will develop a report with recommendations to the BOC Board of Directors.

More Activities Now Count for EBP CEUs

We heard the requests for more ways to earn EBP CEUs, and we are pleased to offer them for the 2016-2017 reporting period. The expanded list will help Athletic Trainers (ATs) receive credit for activities that rely on EBP principles but were not previously counted under this category. Newly-eligible EBP activities are listed at right.

ATs can search the BOC's new online directory to find all BOC approved home studies and live events, including EBP Category programs. The directory is continuously updated. Complete information on eligible EBP Category programs is available in the 2016-2017 Certification Maintenance Requirements document.

New Ways to Earn EBP CEUs

Qualifying journal quizzes* that were previously counted in Category A

Accreditation Council for Continuing Medical Education (ACCME)
Category 1 CME programs offered by BOC Approved Providers

Authorship of a peer-reviewed journal article addressing patientoriented clinical research or translational research

Post-certification coursework from a CAATE accredited AT post professional program


Accredited medical or healthcare provider residency or fellowship with a focus closely related to athletic training

Graduate of a PhD/EdD/DSc/DAT program may qualify if dissertation has a narrow focus of athletic training

* For journal quizzes to qualify, the journal must be peer-reviewed and published by a BOC Approved Provider. Examples include *Journal of Athletic Training* and *International Journal of Athletic Training* and *Therapy*.

STATE REGULATORY NEWS

The BOC's involvement with state regulatory action in the first quarter of 2016 includes the states in the table below. States have brought or considered 196 bills that mention athletic training or Athletic Trainers. These states are illustrated in the map at right. At the federal level, 6 bills affecting the profession have been considered. State and Bill Number	Action
Arizona	 BOC was notified by the Arizona Board of Athletic Training of potential legislation that would, among other items, repeal AT licensure BOC sent a letter opposing the AT provision of the bill ATs were successfully taken out of the bill Licensure remains a requirement for ATs in Arizona
Colorado SB161	 Bill drafted to keep registration If bill is not passed, ATs will no longer be regulated as of July 1, 2016 BOC sent a letter of support of registration Bill has passed the Senate and moved to the House
Connecticut SB00356	 Bill drafted to update AT practice act and allow ATs to practice to the full extent of their education and training BOC sent a letter of support Bill received a favorable fiscal analysis report
Illinois HB6231 SB2742	 Bill drafted to update AT practice act and allow ATs to practice in settings not included in the current practice act BOC sent a letter of support Unrelated to the bill, the department sent BOC draft of updated rules BOC reviewed the rules and provided feedback
Minnesota HF3038, SF2609	 Bill drafted to update AT practice act and to go from registration to licensure BOC sent letter of support Bill to be carried over to the next legislative session
Mississippi	 Updated rules were proposed and the BOC provided feedback
New Hampshire HB1213	 Bill introduced to repeal AT law BOC sent letter of opposition The bill failed
North Carolina	 Bill drafted to repeal AT law BOC sent letter of opposition Senator Wells replied to our letter with questions, and the BOC responded Bill has been put on hold for further investigation; with a short session, the bill will likely be revisited in 2017
North Dakota	 Board requested assistance with online licensure renewal process BOC submitted a proposal, which has been accepted
Utah	 Rules were proposed for clarification regarding direction of a physician BOC submitted a letter to the Division of Occupational & Professional Licensing (DOPL) and its counsel supporting a clarification It was determined that a rule change was not necessary, but rather a clarification was noted in meeting minutes
Washington	 Updated rules were proposed, and the BOC provided feedback

New **BOC Practice Analysis** Published


The BOC is pleased to announce a new version of its practice analysis. *BOC Practice Analysis*, 7th Edition, will become effective for BOC exams beginning April 2017 and for continuing education beginning January 1, 2018.

PA7 identifies essential knowledge and skills for the athletic training profession and serves as a blueprint for exam development and continuing competence programming.

Candidates Will See New Format for Exam Results

The BOC has recently changed the way exam results are shared.

Effective with the March/April 2016 BOC exam, candidates who **pass** the exam will now see an exam result of PASS, not an actual exam score, on the exam results letter.

A passing result on the BOC exam indicates a candidate has met the entry-level standard. As a result, the actual exam score becomes irrelevant once the passing standard has been met. Since the exam is designed to identify individuals who have met a specific threshold, it would be inappropriate to use an exam score to compare passing candidates (e.g., a candidate who scores a 600 is not

necessarily more qualified or competent than a candidate who scores a 550 when the passing standard is 500).

Results will be displayed as follows:

Candidates who **fail** the exam will continue to see an exam score.


The **BOC** Candidate Handbook and website have both been updated to reflect these changes.

AT Insight: Peak Times for CE Participation

We'd like to share with you a few data points about BOC Certified Athletic Trainers following the December 31, 2015, BOC certification maintenance deadline.

As of March 1, 2016:

- 41,939 ATs with a previous expiration date of December 31, 2015, had completed all of their requirements and now have a December 31, 2017, expiration date (93%)
- 3,108 individuals had an Expired certification status due to not completing 2015 requirements (7%)
- 45,990 individuals were Certified (including 4,051 ATs who earned the BOC certification in 2015 or 2016)



The chart above shows the percentage of ATs who had completed their requirements at certain dates leading up to the December 31, 2015, deadline. As you can see, an overwhelming majority of ATs completed their CE requirements in December, at the tail end of the reporting period.

Updated Standards Document to Be Published

The BOC Board of Directors recently approved an updated version of the BOC Standards of Professional Practice, which will be effective September 1, 2016. It will be published in full in the summer edition of Cert Update.

The BOC Standards Committee's goal was to streamline the document with the understanding that the Professional Practice and Discipline Committee uses this document to determine practice violations. Last updated in 2006, the new version aligns with other healthcare

professions while maintaining its relevance for Athletic Trainers.

A public comment period was open last fall. The Standards Committee reviewed the feedback and made a few modifications. The BOC Standards of Professional Practice is reviewed by the BOC Standards Committee and recommendations are provided to the BOC Board of Directors. The BOC Standards Committee is composed of 5 Athletic Trainer members and 1 Public member.
