 resolutions that protect the public. There were 68 attendees from 28
 states, DC and Canada.

- Facilitated BOC Approved Provider focus groups to fine tune structure for targeted resources and support services




CONTINUING PROFESSIONAL CERTIFICATION (CPC) RESEARCH & DEVELOPMENT
